## **NEW BUSINESS**

a. Special Land Use Application, Public Hearing, and Site Plan Review for a communication tower on the Wiley property.

Chairman Visel opened the Public Hearing at 6:03pm to consider the Special Land Use Application of PT Tower Development for the installation of a communications tower on the Wiley property. Fred Low from PT Tower addressed each of the Ordinance's Specific Standards for communication towers (23.7.3).

Chairman Visel opened the Public Hearing at 6:24pm to consider the Special Land Use Application of the Ruzick family for conversion of an existing facility on Portage Road for use as a vehicle sales, service, and repair facility. As the plan, with the requested waivers, met all the Standards for approval (24.6.2), a motion to approve the site plan was made by Eric Jasiak with support from Greg Feldmeier, pending completion of signage decisions (to be reviewed and approved by Administrator Hamilton).
