Kalamazoo County Commissioner John Gisler encouraged support of the May 3, 2016, Special Election Proposals:

Kalamazoo County Countywide Law Enforcement And Safety Millage Proposition. The proposal will permit the County to restore 1.4491 mills of the 1.5 for Law Enforcement, now expired, for six (6) years (2016-2021).

Kalamazoo County Transportation Authority seeks authorization from the electors to levy up to 0.315 mills for a period of five (5) years.

Supervisor Ulsh, Zoning Administer Chris Hamilton and Ryan Hunter, owner of H&H Feed discussed the violation issues with the new construction at the business. Schoolcraft Township, and South Central Michigan Construction Code Inspections will continue working with Mr. Hunter on compliance with state and local ordinances.

Kalamazoo County Road Commission 2016 road projects contracts have been signed. The Road Commission will begin filling pot holes soon.
