APPROVAL OF AGENDA:

A motion was made by Dave Aubry with support from Len Jaworski to approve the agenda as issued. **Motion carried 5-0**

MINUTES OF PRIOR MEETING:

A motion was made by Len Jaworski and supported by Dave Aubry to approve the minutes of the October 7, 2013 meeting, without correction. No meetings were held in November, December, or January. <u>Motion carried 5-0</u>

CITIZEN TIME ON NON-AGENDA ITEMS:

NEW BUSINESS

a. Weber Specialties Site Plan Review

Scott Musser presented the Weber Site Plan for a building addition on US131. Weber plans to move additional powder coating activity to the site. The Site Plan was discussed and considered to meet all requirements when the site survey is completed. A motion was made by Len Jaworski, supported by Ken Hovenkamp, to approve the Site Plan submitted, pending receipt of the site survey by the township zoning administrator.

b. Split-Zoning

Attorney Rolfe discussed the problematic zoning issues which arise when a single parcel encompasses more than one zone. The Commission determined that a subcommittee should review such split-zones in the Township and prepare a recommendation moving forward to the full Commission. Aubry, Bibart, and Visel volunteered to work with Supervisor Ulsh on the issue.

c. KCRC Road Vegetation Management Policy

The Commission reviewed KCRC's newly revised policy dealing with roadside vegetation management along county roads. The revised policy places more responsibility on the land owner for managing tree and brush removal.

OLD BUSINESS

No items were discussed.

REPORT FROM THE TOWNSHIP BOARD

Ken Hovenkamp updated the Commission on Township Board activities including zoning enforcement and increased road repair spending scheduled in 2014.

REPORT FROM THE ZONING BOARD OF APPEALS No report was received.

Attorney Rolfe noted that the Commission will determine meeting dates for the upcoming fiscal year, as well as election of officers, at our March Meeting.

Attorney Rolfe also updated the Commission on possible changes to the Right to Farm Act which could impact future zoning issues.
