## **APPROVAL OF AGENDA:**

## **MINUTES OF PRIOR MEETING:**

A motion was made by Dave Aubry and supported by Ron Avis to approve the minutes of the December 1, 2014, meeting, without correction.

## **CITIZEN TIME ON NON-AGENDA ITEMS:**

Supervisor Ulsh updated the Commission concerning two upcoming issues: site plan review for a new medical facility on US131 and Prairie Edge Estates possible site condo designations.

### **NEW BUSINESS**

No items were discussed.

### **OLD BUSINESS**

### a. GAAMPS Farm Markets

The Commission discussed Farm Markets section of attorney Rolfe's memo of 5/8/14.

Regarding "roadside stands", the Commission generally favored inclusion of this use in the ordinance and its proposed definition. Commission members also favored appropriate setbacks, consistent with the parcel zoning, to protect adjoining residences.

Regarding "farm markets", the Commission generally favored a minimum of 50% <u>home grown</u> component for farm products including processed farm products. Commission members generally favored up to 50% <u>non-home grown</u> component for farm products including processed farm products. The Commission favored addressing all other activities, services, and parking through existing ordinance requirements. Commission members favored appropriate setbacks, consistent with the parcel zoning, to protect adjoining residences.

Regarding Farmer's Market, The Commission favored addressing this aspect through existing ordinance requirements.

Attorney Rolfe will draft proposed new ordinance language covering roadside stands and farm markets for Commission consideration.

### b. Energy Generating Facilities

The Commission reviewed and discussed Attorney Rolfe's 12/1/14 memo addressing potential land use issues for solar energy generating facilities. Commission members generally agreed to the definitions, applicable zoning districts, and approval standards (1-10) proposed to be included by attorney Rolfe.

Attorney Rolfe will draft proposed new ordinance language covering Solar Energy Generating Facilities for Commission consideration.

## REPORT FROM THE TOWNSHIP BOARD

Ken Hovenkamp and Attorney Rolfe updated the commission on actions and activities concerning the 23<sup>rd</sup> street motocross facility as well as Township activity concerning dangerous buildings.
