**Public Comment:** Property owner, Jack Wiley, Jr. told the board that he would like an amendment to the April 14, 2020 minutes of the Schoolcraft Township Board as his correspondence of March 30, 2020 was not included. Wiley then advised the board that he had two witnesses to a Schoolcraft Township employee using township equipment at his residence.

The accused Schoolcraft Township employee advised that the Kubota tractor that Mr. Wiley's witnesses saw was that of another township resident, and that there is video from the Swan Park security system to substantiate it.

Mr. Wiley offered his apology.

**Zoning Board of Appeals:** Approved a zoning variance request at a property located at 1335 Panama Street.

**Planning Commission:** Approved a Kevin Paffhausen site plan for property located at 12650 North US 131 pending two requirements yet to be met.

### **Members Time:**


Supervisor Ulsh reported of new construction and improvements coming to DeNooyer Ford.
