The agreement for Consumers Power Company is expected to be presented to the board at the July 9, 2013 regular meeting of the Schoolcraft Township Board.

Attorney Rolfe informed the board that the Jeffery and Kelly Blodgett home at 2259 East W Avenue has been has tagged as a Dangerous Building under Schoolcraft Townships Dangerous Building Ordinance #233, Section, -2 by Michigan Township Services. Schoolcraft Township Enforcement Officer Tina Straw will serve notice to ne owners.

Motion by Mongreig with second by Feldmeier to adopt the Principles of Governance as the official policy of Schoolcraft Township, pledging to maintain the highest standards and traditions of Michigan townships. Motion carried 5-0

The Township will implement a \$100.00 Administrator Site Plan Review fee.

ipervisor Ulsh provided the board with a map of parcels owned by the Mill of South County that have been offered to the township for purchase. Supervisor Ulsh suggested the board members look at the property prior to the July meeting for discussion.

Road Committee Chair Scott reported the following Kalamazoo County Road Commission progress: Chip seal 14<sup>th</sup>, YZ Avenue to XY Avenue
Chip seal Oakland Drive, U Avenue to Portage City Limits
Crack seal, Chip seal, 14<sup>th</sup> Street, Lyons to U Avenue
Crack seal, Chip seal U Avenue - Portage Road to 200"

Chair Scott will contact Jim Beaudoin about the product being used for chip seal as it appears to be regular gravel. She will also mention reports of potholes from constituents.

Siegfried Crandall installation of new server is complete. The township budgeted \$21,000.00 for in capital outlay for the purchase and installation of the server, leaving approximately \$9,000.00 in the account.

Treasurers Scott's computer is over three years old and Siegfried Crandall technician and BS&A Software Company advise that the treasurer get a new one. IT says treasurer should have new computer each year per the programs that are used.
