Bob Sacksteder, resident and Barton Lake property owner address the board regarding the accuracy of a proposed Public Access at the North end of Barton Lake in the Village of Vicksburg limits.

Trustee Hovenkamp, who has been involved in talks with the Village of Vicksburg, stated that the Angels Crossings development has access at the channel leading into Barton Lake. Their interest, said Trustee Hovenkamp is for a launching place for canoes and kayaks, and strictly non-motorized vessels. Hovenkamp stated that no permission has been granted by the Village of this request. Hovenkamp also stated that there is no Keyhole Ordinance in the Village of Vicksburg, and that there would be a low impact – even if the projected site gets off of the ground. He also reported that an email will be going out from the lake association soon.

Mr. Sacksteder then spoke of the Barton Lake property owners trust in Schoolcraft Township, as the former Township Supervisor said that they, (Vicksburg Village/Angles Crossings), would never keyhole the lake.

Mr. Sacksteder reported the sightings of an earthmover at the village/development property last summer, 2012. There were also a Pontoon Boat and speed boat moored there following the clearing. He asked about assessments to the Angels Crossings Development property owners.

Trustee Hovenkamp stated that there was a bulldozer clearing the lot, and a path to the water was brush hogged, and that the truth is that bulldozing did not go to the water.

Trustees Hovenkamp also said that if there is access granted to Angles Crossing/Vicksburg Village, they will be willing to pay the assessment.

Trustee Feldmeier asked if there was any concern that it would evolve over the next year or two to become a keyhole issue, and is Vicksburg thinking of putting a key holing ordinance in place.

Mr. Sacksteder asked if the annexation was a "give away" years ago when the property was annexed to the village.

Supervisor Ulsh stated that he was against the annexation of Schoolcraft Township property from the start. And Clerk Mongreig, while she was not a board member at the time stated that she was against the annexation, and is against village having access to Barton Lake.

Attorney Rolfe asked Trustee Hovenkamp if he knew by what means the village will handle this issue, and stated that since the property is within the limits of the Village of Vicksburg; Schoolcraft Township has no legal parameters at all.

Supervisor Ulsh reported that he visited the Jack Wiley, Sr. property on Howard Lake, and saw an old park model trailer with a walk out basement, 5–6 trailer pads with full power hookup, along with 3 cabins on the property. There are three docks; one with a submerged pontoon boat. He noted that the property is not that well-kept. The camping spaces are rented in the summer time and the campers leave in the fall.

Supervisor Ulsh explained to Jack Wiley, Jr. the Township's liability in allowing the camping in the Rural Residential zoned district. J Wiley, Jr. stated that he may build home on the property at some time.

Supervisor Ulsh suggested the Wiley family speak with their personal attorney, and believes that the Wiley's do understand the township's predicament.

Attorney Rolfe stated that given the potential for costs to vary from year to year for the Sunset Lake Weed Assessment the township must obtain information from the Professional Lake Management to consider the need of a redetermination. Supervisor will contact the Professional Lake Management to begin discussions.
