**ORDINANCE AMENDING EXISTING STATE CONSTRUCTION CODE ORDINANCE
(ORDINANCE NO. 113, AS AMENDED BY ORDINANCE NO. 207)
TO ADDRESS FLOODPLAIN MANAGEMENT PROVISIONS
OF THE STATE CONSTRUCTION CODE**

An Ordinance to confirm the prior designation of an enforcing agency to discharge the responsibility of Schoolcraft Township and to designate regulated flood hazard areas under the provisions of the State Construction Code Act, Act No. 230 of the Public Acts of 1972, as amended, all supplementary to the existing Schoolcraft Township State Construction Code Ordinance.

ORDAINS:**

SECTION 1: TITLE

This Ordinance may be cited by its above-designated title.

SECTION 2: AGENCY DESIGNATED

Pursuant to the provisions of the State Construction Code, in accordance with Section 8b(6) of Act 230 of the Public Acts of 1972, as amended, the prior designation of the Building Official of Schoolcraft Township as the enforcing agency to discharge the responsibility of Schoolcraft Township under said Act is hereby confirmed. Schoolcraft Township assumes responsibility for the administration and enforcement of said Act throughout the corporate limits of Schoolcraft Township with respect to the subject matter of this Ordinance as a supplementation of the responsibility previously assumed by Schoolcraft Township pursuant to Ordinance No. 113 adopted May 10, 1988 as amended by Ordinance No. 207 adopted September 17, 2001, known as the Schoolcraft Township State Construction Code Ordinance.

SECTION 3: CODE APPENDIX ENFORCED

Pursuant to the provisions of the State Construction Code, in accordance with Section 8b(6) of Act 230 of the Public Acts of 1972, as amended, Appendix G of the Michigan Building Code shall be enforced by the enforcing agency within Schoolcraft Township.

**SECTION 4: DESIGNATION OF REGULATED FLOOD PRONE HAZARD AREAS
BY STUDY AND MAPS ADOPTED BY REFERENCE**

Schoolcraft Township hereby adopts by reference for the purposes of administration of the Michigan Construction Code, and declares to be a part of Section 1612.3 of the Michigan Building Code, and to provide the content of the "Flood Hazards" section of Table R301.2(1) of the Michigan Residential Code, all of the following:

- The Federal Emergency Management Agency (FEMA) Flood Insurance Study (FIS) entitled Kalamazoo County, Michigan (all jurisdictions) dated February 17, 2010.
- All current FEMA Flood Insurance Rate Maps (FIRMS) for Schoolcraft Township, presently consisting of the following panel number(s) of map number 26077C: 0311D, 0295D, 0315D, 0320D, 0409D, 0428D, and 0450D, dated February 17, 2010.

SECTION 5: REPEALS

All ordinances or parts of ordinances inconsistent with the provisions of this ordinance are hereby repealed; provided this Ordinance shall be considered to amend but not repeal any provision of the existing State Construction Code Ordinance referenced herein.

SECTION 6: EFFECTIVE DATE/PUBLICATION

This ordinance shall be effective 30 days after legal publication and in accordance with the provisions of the Act governing same.
