Call to Order: 6:00 p.m. Pledge of Allegiance

<u>Approval of agenda</u>. Motion by Hovenkamp with second by Scott to approve the agenda as presented. **Motion carried 5-0**.

<u>Approval of minutes</u>. Motion by Scott with second by Hovenkamp to approve the minutes of September 9, 2014 Regular Meeting minutes as presented. **Motion carried 5-0.**

<u>Gourdneck Lake Board Discussion</u>: The consensus of the Schoolcraft Township Board is that the township as a whole will not be involved with the Gourdneck Lake Weed Treatment, and that the residents of the lake may form a board which will include representatives from Kalamazoo County departments, City of Portage representative and Schoolcraft Township representative.

<u>Clerk Mongreig informed the Township</u> Board and the Township's Attorney that she had indeed executed the "Certification of Schoolcraft Township Clerk Regarding Adequacy Of Petitions For Submittal Of Ordinance NO. 264 To Electors For Approval Or Rejection."

This action stems from the circulation of petitions for referendum by Mr. Cary Campagna of Command Electronics of Schoolcraft who along with other owners of Command Electronics opposed Schoolcraft Township Ordinance NO. 264 adopted at the August 12, 2014 regular meeting of the Schoolcraft Township Board.

Motion by Feldmeier with second by Mongreig to adopt Resolution of Township Board to Submit Ordinance No.264 to the Electors for Their Approval or Rejection at the Next Regular Election in Schoolcraft Township.

At a previous meeting of the Schoolcraft Township Board Mr. Campagna stated that Meijer and the Tractor Supply Company, both on Shaver Road had to evacuate their buildings due to gas leaks from the Farrell Gas propane company near them. Trustee Feldmeier and Supervisor Ulsh have contacted both companies and the City of Portage and have been told that there have been no complaints reported.

Clerk Mongreig reported on the painting of the roof of the Sexton's Building in the Vicksburg Cemetery, High Absent Voter Ballot requests for the November 4, 2014 General Election, and the annual leaf drop will begin October 15, 2014.

Trustee Hovenkamp reported that the Barton Lake Association will hold a meeting regarding the weed harvesting, and that the board is in need of new members.
