NEW BUSINESS: Site Plan Review: Cloverleaf Storage

Rene Schwindland and Judy Hambly were present to discuss the addition of 20X100 storage building on their 131 site. This future addition was included in the May 2016 site plan. As the submitted plan appeared to be administratively complete and the project appeared to meet zoning and ordinance requirements, a motion to approve the plan, including future additions noted on the May 2016 site plan which meet the zoning and ordinance requirements, was made by Dave Reno with support from Greg Feldmeier.
