Planning Commission Report – Trustee Hovenkamp stated that the Commission will be completing the Master Plan language soon and inquired to the use of the township attorney once the language is complete. Supervisor Ulsh asks that due to financial constraints, the attorney be used only as necessary.

Zoning Board of Appeals Report – none. Supervisor Ulsh reported that Jack Westendorp has accepted the position of alternate on the Zoning Board of Appeals.

Township Park Committee Report: Ryan LaPorte reported the following:

Meetings of the Vicksburg and Schoolcraft Little Boards – 11 and 12 year old state tournament opening ceremony will be July 21, 2012 at Swan Park

Temporary dug-outs will be installed for the season.

The Committee is reviewing a Swan Park Rules Ordinance which will be forwarded to the Township Board for approval. Schoolcraft Little League Opening Day is set for April 28, 2012

\*The township board approved \$25.00 per week park restroom cleaning.

Road Committee Report: Road Committee Chair, Scott reported that Ron Steinacker and Pete Kearns along with Chair Scott and Jim Beaudoin of the Kalamazoo County Road Commission will make the annual drive around the township to review the road conditions.

#### Members Time:

Trustee Hovenkamp Inquired as to the status of the South County Food Pantry. Supervisor Ulsh reported attending a Village of Schoolcraft Board Meeting where he learned that the pantry is secure in its place at the Village Public Works location.

Trustee Hovenkamp expressed concern in the condition of the Webber School at the Gourdneck Prairie Cemetery. Clerk Mongreig stated that two parties in the past month have shown interest in repairs to the school.

Trustee Feldmeier inquired if the US 131 Corridor Sewer Project is "totally dead", "funds gone?"

Supervisor Ulsh said that there is no activity at this time.

Trustee Feldmeier expressed appreciation to the Park Committee.

Clerk Mongreig reported that preparation will begin for the August Primary to be followed by the November General Election.

Supervisor Ulsh stated that 90% of property owners that visited the Board of Review with requests for lowering their land values were granted their request.

The Vicksburg Rotary will be installing fencing at the entrance of the township cemetery on Highway Street in Vicksburg.

Aused car and equipment sales business will be opening at the corner of US 131 and U Avenue, and the former Gold Rush property on US 131may be may soon be under a new owner who would like to move his landscape business there.
