<u>Citizens Time for Non-Agenda Items:</u> Al Reynolds of 1311 East U Avenue, in the R-2 District inquired as to the possibility of raising chickens and ducks on his property.

Attorney Rolfe stated that Mr. Reynolds does not have the opportunity under the current Land Use Plan/Zoning to raise poultry, and that a text amendment to allow poultry i.e. "livestock", would automatically open the Ag Right to Farm Act in any area the Township allows such use, thus Mr. Reynolds was advised that the request could not be permitted.

a.) Outerwears, Inc. IFEC Application:

Attorney Rolfe referenced a resolution and application requesting an Industrial Facilities Exemption Certificate reflecting a total project cost of \$80,023.00 on new Personal Property, as submitted by James Garside of Outerwears, Inc.

Motion by Scott with support by Hovenkamp to open the Public Hearing.

Motion carried 4-0

James Garside told the board that Outerwears, Inc. produces filters for high-powered car and jet skis, and other protective accessories designed for racing and everyday use. Mr. Garside stated that the purchase of a custom cutting table, computer, racks, and printing presses will enable Outerwears, Inc. to increase the capacity for more production and greater part offering efficiency, and would absolutely create more jobs in the future.

Motion by Scott with support by Mongreig to close the Public Hearing.

Motion by Ulsh with support by Scott to approved the Resolution Pertaining to the June 15, 2010 Application of Outerwears, Inc. For an Industrial Facilities Exemption Certificate.

b.) Review of Zoning Ordinance for "catch-all" provision:

Attorney Rolfe reported finding few issues within the Zoning Ordinance. He has advised this township to leave the Zoning Ordinance alone, noting that he will do a thorough review and report findings back to the board.

c.) Municipal Ordinance Violations Bureau Ordinance:

The board directed Attorney Rolfe to draft a Municipal Ordinance Violations Bureau Ordinance which will properly establish the Schoolcraft Township Municipal Ordinance Violations Bureau which will properly establish the proper administration of municipal ordinance violations issued by authorized officials of the Township.

Upon receipt of the proposed ordinance, a special meeting will be scheduled for consideration of formal adoption by the Township.

New Business

a.) Approval of Pension Provider: Motion by Ulsh with support by Mongreig to terminate the Township relationship with Nationwide Financial and move the Township pension plan to Edward Jones. The move will reflect a \$453.00 savings per year. Motion carried 4–0

b.) SCKFA 2010 Draft Audit: Motion by Scott with support by Mongreig to approve the 2010 SKCFA Financial Statements and Independent Auditor's Report.

Planning Commission Report: Trustee Hovenkamp reported that the Planning is at a stalemate with some division between the Planning Commission Members whether or not to meet with farmers of the township prior to going to a public hearing on the Ag District.

Supervisor Ulsh stated that he would like to see the Planning Commission involve the farmers in their discussions prior to holding a public hearing.
