Treasurer Scott reported as a board member of the South Central Michigan Construction Code Inspections that with the impending retirement of Christine Hamilton the board has begun the interviewing process for her replacement, along with electrical, plumbing, and mechanical inspectors.

Trustee Fryling reported that the 2022 road projects have been completed. Trustee Fryling will be attending a Michigan Townships Association educational program in October, 2022.
