Dr. Gail Walter, DVM and Peregrine Falcon Coordinator explained the U.S. Fish and Wildlife Service Urban Conservation Treaty for Migratory Birds, and asked Schoolcraft Township to join in along with number of cities, townships and conservation groups. **Motion by Ulsh with second by Scott to join the cause for "Making Cities Healthier Places for Birds and People". Motion Carried 5-0**

Progressive AE Agreement Barton Lake: Motion by Fryling with second by Stafford to direct Supervisor Ulsh to sign the Progressive AE, Inc. South Kalamazoo County Fire Authority: Trustee Fryling reported that the Authority is discussing the purchase of one to two fire trucks.

Treasurer Scott reported that South Central Michigan Construction Code Inspections continues to interview for blight, and inspection officials.

Mongreig distributed voting histories/comparisons of the 2018 vs 2020 General Elections.

In 2018 Schoolcraft Township had 6,668 registered voter vs 2022 with 7,471 registered voters.

In 2018 1,841, or 27.53% of registered voters turned out

In 2022 4,408, or 59% registered voters turned out.

60.82% females voted while 57.07% males voted.
