**SKCFA Report:** Trustee Fryling reported:

Pride Care EMS has stopped service in South County effective June 8, 2023. Life EMS will cover all South County ambulance routes effective Thursday, June 8, 2023.

The Fire Authority Administrator and the President are working with Siegfried Crandall PC auditors to clarify that funds for a new fire truck are accounted for.

Clerk Mongreig asked for an update on cost recovery of fire calls.

**SCS & Water Report:** U.S. 131 project continues making progress.
