Citizens Time:

A large group of people were in attendance to voice their concerns following erroneous information from face book posts that the Schoolcraft Township Board was acting on a firewood ordinance at the Tuesday, July 1, 2023 board meeting. There were many accusations made that the "ordinance" was on the agenda for the July 11, 2023 meeting. Supervisor Ulsh stated that what has happened is a tragedy as someone took it upon themselves to go out on face book to spread rumors. Supervisor Ulsh attempted again and again to inform the crowd that at no time was the "ordinance" on the July 11, 2023 agenda. Clerk Mongreig read the portion of the June 2023 minutes indicating that there would not be discussion of the "ordinance" in July, and that Supervisor Ulsh would be visiting the subject of wood piles used as fencing with surrounding township supervisors. Clerk Mongreig suggested rather than following face book accusations that folks go to the Schoolcraft Township web page for information, or better yet, contact or visit the township office before passing on random, inaccurate posts.

Again, Supervisor tried to assure the group that there will be no action on a wood pile ordinance.

Kalamazoo County Commissioner, Wendy Mazer reported to the board that Kalamazoo County will soon be presenting a monthly newsletter to constituents, and that the County will be holding a retreat for work on their budget.

John Gardner, President of the Schoolcraft Little League reported on the Little League plans for matching dugouts on fields 3, 4 & 5 and fencing at the fields at Swan Park including Field 7. Schoolcraft Township is hosting District 15, Little League All Star Tournaments this week.

John Spencer District Manager, representing State Representative, Matt Hall gave an introduction along with offers of assistance with constituents' questions and needs at the State level.

Supervisor Ulsh explained the new wastewater treatment plans with St. Joseph County Townships which is proposed for US 131, south of Schoolcraft.

Motion by Mongreig with second by Stafford to approve the following Ordinance to Amend Schoolcraft Township's Zoning Ordinance as recommended by the Schoolcraft Township Planning

SCHOOLCRAFT TOWNSHIP ORDINANCE TO AMEND TOWNSHIP'S ZONING ORDINANCE

HOOLCRAFT TOWNSHIP ORDAINS:

tion 1. Amendment of Article 17.2

oulcle 17.2 of the Township's Zoning Ordinance is amended to remove the following language "where the 'footprint' of the use (ground area of principal building) does not exceed a total of 15,000 square

Section 2. Amendment of Article 24.12

Article 24.12 of the Township's Zoning Ordinance is amended to add "The administrator shall consult in writing with the Planning Commission chair prior to Administrative Site Plan Review approval." Article 24.12(1)(B) is also amended to remove "and not exceeding a cost of \$40,000." Section 3. Validity and Severability

Should any portion of this Ordinance be found invalid for any reason, such holding shall not be construed as affecting the validity of the remaining portions of this Ordinance. Section 4. Repealer

All other ordinances inconsistent with the provisions of this Ordinance are hereby repealed but only to the extent necessary to give this Ordinance full force and effect. Section 5. Effective Date

This Ordinance shall be published and take effect seven days after publication as provided by law.

Integrated Technologies: (IT) Service: Per recommendation by Scott and Assessor Brousseau - Motion by Scott with second by Mongreig to change I.T. provider to Hi-Tech Integrated Technologies.

South Kalamazoo County Fire Authority: Trustee Fryling reported

The Authority approved amendments to the by-laws. A copy has not been received at the Township.

Trustee Fryling explained to audience that fire protection and EMS services are administered by the 4 townships and 2 village entities of South County.

Capital Improvements – No major concerns. Siegfried Crandall is reviewing the Fire Authority budget. Neither Schoolcraft nor Vicksburg Villages are on board with the final budget report.

he Authority purchased a used tanker from Richland last year.

New tanker- nothing under \$800,000 capital imp. Halted due to audit. Must order by 7-7, or The Authority is able to purchase the tanker with zero down at 6.24% interest rate. Prepay without penalty. \$846,473.00 for the tanker. 27-30 month delivery. Finance agreement (lease) at end of the lease \$1 pay out \$88,840.00 per year which is similar to the funds set aside annually by Authority

Authority going ahead with the need to revamp capital improvement plan as the price is almost double what trucks were going for last year. 4-1 vote

Cost Recovery – accident coverage recovery. Wakeshma Township suggested prepare /assign someone to the program as often time court time involved. Fryling will obtain a copy of the ordinance from Wakeshma.

Treasurer Scott would like to receive monthly updates as there were 3 fires in last month with no

Fryling receives reports from the Chief on weekly basis. Mongreig requested weekly reports from the Chief with correct addresses.

Treasurer Scott requested responses to rescues when Schoolcraft Township is charged. Fryling will aft a letter from Schoolcraft Township to the Authority.
